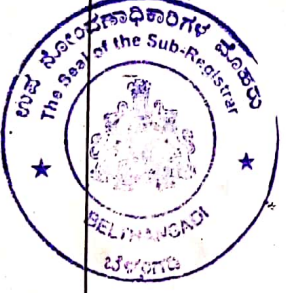

Ø1) **CREATION OF THE TRUST:** The author has this day transferred and given unto the Trustees a sum of Rs. 500/- (Rupees Five Hundred only) to be held upon trust together with all the income arising therefrom and all the accumulations and accretions thereto for the intent purpose and object herein contained.

Ø2) **NAME AND ADDRESS OF THE TRUST:** The name of the Trust shall be PRASANNA EDUCATION TRUST and the office of the Trust shall be, for the present, Opposite to Government Hospital, Belthangady, DAKSHINA KANNADA DISTRICT and or such other place/s as the Trustees may determine.

Ø3) **OBJECTS OF THE TRUST:**

a) To formulate and implement schemes for the spread of education with special importance to education of Poor Students by providing Mid-day Meals, Books and clothing .

b) To educate people especially people from the poor classes in the field of Agriculture and allied activities to make them stand on their own feet.

c) To adopt Villages and to improve health of the rural poor by providing them required help and support.

d) To Start Environment Awareness Centers and Pollution Awareness Centers to educate and encourage people to avoid pollution of the surroundings by plantations of trees etc.

e) To establish and administer and to assist in establishing Cultural Centres for promoting Cultural Activities of the Rural People.

f) To establish and administer and to assist in establishing Hostels, Museums, Reading Rooms, Libraries and Research Institutions.

f) To support and render financial assistance to Charitable Educational Causes, Institutions and Organisations, Trusts, Societies etc. in the form of donations, Loans or otherwise on such terms as the Trustees deem fit or which in the opinion of the Trustees will help the realisation of all or any of the objects of the Trust.

g) To give Scholarships, Awards, Stipends, Honorarium to promote and encourage Scholarship and research especially in the field of Environment and Nature.

13) **POWER OF TRUSTEES:** The Trustees shall have full power and authority to administer the Trust, its properties and funds and to do all acts, deeds and things as are calculated to further the objects for which the Trust is created. They shall be entitled to act even if their number is reduced to less than three for the purpose of filling up any vacancy on the Board of Trustees.

Without prejudice to the generality of the foregoing the Trustees shall have power for the purpose of the Trust :

- a) To acquire properties by purchase, lease, grant, gift or otherwise including immovable and moveables.
- b) To sell or Mortgage the properties of the Trust.
- c) To Borrow any money with or without security and repay the same.
- d) To open Bank accounts and provide for operation thereon through the Managing Trustee or as per his directions.
- e) To enter into all contracts and to rescind the same.
- f) To invest Trust Funds in Fixed Deposits with Nationalised Banks, Unit Trust of India, Government Securities or any other investments as provided for in Section 11 (5) of the Income Tax Act, 1961 read with Section 13(1)(d) of the Income Tax Act, 1961.
- g) To receive, collect and enforce recovery of moneys due to the Trust and grant receipts and discharge therefor.
- h) To appoint, terminate, suspend and otherwise deal with the employees of the Trust.
- i) To institute and defend all suits and proceedings
- j) To appear and act before all governmental and other Public authorities and courts and tribunals.
- k) To incur expenses connected with the administration of the Trust.
- l) To apply the properties and funds of the Trust for the objects of the Trust.
- m) To let any portion of any immovable property forming part of the Trust fund at such rent and for such period and at such terms and conditions as they may think fit and accept surrender of any lease.

n) To accept gifts, donations or contributions in so far as they are not inconsistent with the objects of the Trust and all such gifts, donations and contributions shall form part of the corpus of the Trust.

o) To establish Trusts and other institutions having objects similar to those of this trust. Provided further no amendments shall be made which may prove to be repugnant to the provisions of Section 2(15), 11 to 13 and 80G provided further that the powers of the Trustees shall be so exercised as to ensure that the Income of the Trust would be exempted U/Sec. 11 of the Income Tax Act, 1961 as read with Section 12, 12(a) from time to time. It is further clarified that the power of investment of the trust funds including those mentioned in clause 12(f) shall be exercised in accordance with the provisions of Section 13(1)(d) read with section 11(5) of the Income Tax Act, so as to ensure exemption under the act.

Any donations made with a specific direction that the amount donated shall form part of the corpus of the Trust should not be treated as income. Such amount shall form part of corpus of Trust.

14) **TRANSACTION OF BUSINESS OF TRUSTEES:** The meetings of the Board of Trustees shall be held at least once in three months and in one of such meetings the Trustees shall review the accounts for the year and sanction the budget allotment. The office of the Trustees shall be honorary and the Trustees are not entitled to any remuneration or allowance for carrying out their duties. The quorum for the meeting shall be two members personally present and the Managing Trustee shall preside over the meeting.

The decisions of the Board of Trustees shall be taken either unanimously or by majority and if the Board is equally divided, the Managing Trustee shall be entitled to a casting vote.

15) **ACCOUNTS OF THE TRUST:** The Trustees shall keep proper books of account of the Income and Expenditure of the Trust and it shall be closed every year on 31st MARCH. They shall be audited by a Chartered Accountant duly appointed.

16) **INDEMNITY:** The Trustees shall at all times stand indemnified in respect of any act that may have been bonafide done in respect of matters relating to the Trust.

17) **IRREVOCABILITY AMENDMENTS TO THE TRUST:** The Trust hereby created is irrevocable. The provisions hereof may be amended, if the Trustees for the time being unanimously or by not less than 3/4th majority consent; provided that the character of the Trust as a Public Charitable Trust established for the promotion of the objects herein before set forth, shall not be altered.

18) AMENDMENT CLAUSE: No amendments to the Trust deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 & 13 and 80G of the Income Tax Act, 1961.

Further no amendments shall be carried out without the prior approval of the Commissioner of Income Tax.

19) MINUTES OF THE MEETINGS: A minutes book shall be maintained at the office by the Board of Trustees. Minutes of all meetings, appointment and entry into the office of every new Trustee and all other proceedings of the Board of Trustees shall be entered and recorded in such minutes book and shall be signed by the chairman of the meeting either at the conclusion thereof or at a subsequent meeting when they are duly confirmed.

20) BYE LAWS: The Trustees may make bye-laws for regulating the Management of the Trust and other matters.

21) FAILURE OF THE TRUST: In the event of the determination of Trust or dissolution for any reason, the Trustees shall make over or transfer the properties of the Trust to a Charitable Trust or Charitable Institution having similar objects to those of this Trust and which enjoy recognition U/Sec 80G of the Income Tax Act, 1961 as amended from time to time provided that under no circumstances, the properties of the Trust at the time of dissolution or at any time shall be distributed among the Trustees.

22) ACCEPTANCE OF THE TRUST: The Trustees above named accept this Trust.
